NOTICE: PRIORITY ENROLLMENT FOR STRAUS DISPUTE RESOLUTION ELECTIVES

NOTICE: NEW CERTIFICATE IN INTERNATIONAL AND COMPARATIVE LAW

The Certificate in International and Comparative Law offers students the opportunity for exposure to different facets of international law and international living in order to better position them for an international career.

The certificate seeks to encourage students to expand their career goals by facilitating overseas experiences in one of the Semester or Summer overseas programs in London, Copenhagen, Augsburg, Rwanda and Uganda. Students will be mentored by the international faculty through international courses, internships, moots and memberships as well as the initial application interview. Although not required, students are encouraged to develop language skills and direction is given to help achieve this. In order to complete the certificate, students are required to attend at least one of the overseas programs and complete 14 units of required and elective courses.

D & L STRAUS DISTINGUISHED VISITING PROFESSORS

AKHIL REED AMAR (Advanced Constitutional Law: Reading The Constitution): Akhil Reed Amar, Southmayd Professor of Law at Yale Law School, is considered by many to be the most outstanding constitutional law scholar of his generation. He was the second youngest person to be tenured and given a chair in the Yale Law School's history. As an undergraduate he attended Yale College, where he majored in history and economics, won many prizes, earned a perfect grade point average, and was a star debater. Later, as a student at Yale Law School, he served as editor of the *Yale Law Journal*. Professor Amar is the author of several distinguished scholarly books and law review articles, has been cited by the Supreme Court often and is one of the most frequently quoted academics in America. He was also a consultant to the popular television show "The West Wing," and serves on the Board of Directors for the National Constitution Center.

ELLEN PRYOR (Law and Morality Seminar and Torts I): Ellen Pryor is the Homer R. Mitchell Endowed Professor of Law at SMU Dedman School of Law; she also serves as an Associate Provost for SMU. She graduated from Rice University and from the University of Texas School of Law. At the University of Texas School of Law, she served as Editor-in-Chief of the Texas Law Review and received awards for the highest grades in Torts, Contracts, Property, and Civil Procedure. After graduation from law school, she was a judicial clerk to the Honorable Carl McGowan of the United States Court of Appeals for the D.C. Circuit. While practicing civil litigation for four years in Dallas, she received the Dallas Bar Association's Pro Bono Award of the Year, and the State Bar of Texas' Frank Scurlock Award for Delivery of Legal Services to the Poor. At SMU, she has received the Don Smart Law School Teaching Award, the SMU Altshuler Distinguished University Teaching Award, and SMU's United Methodist Scholar-Teacher of the Year Award. She received the 2006 Robert B. McKay Law Professor Award from the American Bar Association's Tort Trial Insurance Practice Section.

She is a co-author of the 4th edition of *The Law of Torts* (West), and *Advanced Torts* (West). Her writings in the areas of tort law, disability, compensation, and professional responsibility have appeared in, among other journals, the *Harvard Law Review*, *Virginia Law Review*, *Georgetown Law Review*, *Journal of Legal Studies*, and *Texas Law Review*. Since 2008, she has been serving as the Coordinating Reporter for the American Law Institute's *Restatement (Third) of Torts*, and is currently drafting the portion of the *Restatement* relating to the liability of those who retain independent contractors.

VISITING PROFESSOR

BEATE GSELL (Advanced Property Issues-Co-teaching with Professor Wendel): Beate Gsell is professor of law at the University of Augsburg, where she holds a chair in civil law, civil procedure, european private law and conflict of laws. She studied law in Göttingen, Aix-en-Provence (France) and Tübingen (1988-1993). Having passed the First State Examination in 1993 in Tübingen (Germany), she successfully completed the practical legal training in 1995 (Second German State Examination). Beate Gsell was awarded of the degree of doctor juris, University of Tübingen (Germany) in 1997. Thereafter she worked as a research assistant at the Universities of Tübingen (1997-2000) and Bonn (2000-2002) and completed her post-doctoral dissertation in the area of product liability. She accepted a professorship at the University of Munich (LMU) in 2002 and was called to the University of Augsburg in 2003. In 2009 and 2010 she declined calls to the Universities of Tübingen and Potsdam. Professor Gsell is author of books, commentaries and articles on German and European Private Law with emphasis on German Law of Obligations.

NEW FACULTY MEMBERS

MICHAEL HELFAND (Contracts I): Michael Helfand received his J.D. from Yale Law School in 2007. In 2009, he received his Ph.D. in Political Science from Yale University, where his fields included Contemporary Theory, Political Philosophy and American Politics. Prior to joining the law faculty in 2010, Professor Helfand was an associate at Davis Polk & Wardwell LLP, where his practice focused on complex commercial litigation. Before entering private practice, Professor Helfand clerked for the Honorable Julia Smith Gibbons of the United States Court of Appeals for the Sixth Circuit.

Professor Helfand's primary research interests are law & religion, arbitration, constitutional law, and contracts. In particular, he has worked extensively on the intersection of group rights and the law, including religious arbitration, equal protection clause jurisprudence, and political theories of toleration. Professor Helfand has published in the *University of Pennsylvania Journal of Constitutional Law*, the *William & Mary Bill of Rights Journal*, and the *Journal of Law & Religion*.

GREGORY MCNEAL (Ethical Criminal Practice): Professor McNeal teaches courses in criminal law, national security law and ethics. His research focuses on the institutions and challenges associated with global security, with a particular substantive focus on national security law, criminal law & procedure, and international criminal law. Prior to joining the Pepperdine Faculty he taught law at the Pennsylvania State University. Before entering the academy Professor McNeal co-directed a transnational counterterrorism program for the U.S. Department of Justice. He also served as an advisor to the Chief Prosecutor of the Department of Defense Office of Military Commissions on matters related to the prosecution of suspected terrorists held in the detention facility in Guantanamo Bay Cuba. Before that he served as an officer in the U.S. Army. He has consulted with members of Congress, the Netherlands Ministry of Foreign Affairs, the Iraqi High Tribunal, and Fortune 500 companies on matters related to counterterrorism, international criminal law and national security.

His co-edited book "Saddam On Trial: Understanding and Debating the Iraqi High Tribunal" was selected as one of three finalists for L'Association Internationale de Droit Penal's 2007 Book of the Year Award. During and after the trial of Saddam Hussein, excerpts from the book were translated into Arabic, and in an effort at judicial outreach, were read over the radio to the Iraqi people. He is co-author of the forthcoming book "Counterterrorism Law Across Borders: Differing Perspectives on Rights and Security." Professor McNeal earned his undergraduate degree in international relations from Lehigh University, his masters with distinction from American University, his law degree from Case Western Reserve University with an honors concentration in international law courses, and he is a doctoral candidate at the Pennsylvania State University. During law school Professor McNeal was selected as executive editor for *The Harvard Journal of Law and Public Policy* (Symposium Edition). Professor McNeal is active in his academic field, serving as the Editor in Chief of *The National Security Report* the flagship publication of The American Bar Association's Standing Committee on Law and National Security, he also serves as a member of the Executive Committee of the AALS Section on National Security Law, and Vice President of the American National Section of the International Association of Penal Law. His non-academic writing has appeared in publications such as *The New York Times*, *The Washington Times*, and *The Baltimore Sun*. He has appeared on NPR, BBC, C-SPAN and other national media outlets as an expert commentator on counterterrorism and international law and has been quoted by *Time Magazine*, *The New York Times* and *The Associated Press* among others. DISTINGUISHED VISITING PROFESSORIAL LECTURER

JACK BEARD (National Security Law): Jack Beard is a Professorial Lecturer at the UCLA School of Law where he has taught since 2005 and where the graduating class of 2008 elected him Professor of the Year. Professor Beard received his B.S.F.S, magna cum laude, from Georgetown University, his J.D. magna cum laude, from the University of Michigan, and his LL.M. in International and Comparative Law, from Georgetown Law. From 1990 to 2004, he served as Associate Deputy General Counsel (International Affairs), Office of the Secretary of Defense, and was responsible for legal matters related to international defense cooperation, status of forces issues, nuclear nonproliferation activities, and programs assisting states in the dismantlement of weapons of mass destruction. He served as the senior legal adviser on U.S. Government delegations negotiating numerous international agreements with states in the former Soviet Union and the Middle East. Prior to joining the Office of General Counsel in 1990, he held several positions in government and was also previously engaged in private law practice in Washington, D.C. As an adjunct professor, he received awards for his teaching at both Georgetown Law and the Johns Hopkins School of Advanced International Studies. Professor Beard has written articles on international law and the use of force, the law of war, terrorism, and international efforts to prevent the proliferation of weapons of mass destruction.

DISTINGUISHED VISITING PRACTITIONERS IN RESIDENCE

MARK A. BEHRENS (Advanced Torts Seminar): Mark A. Behrens is a partner in the Washington, D.C.-based Public Policy Group of Shook, Hardy & Bacon L.L.P. For almost two decades, Mr. Behrens has been extensively involved in product liability law, defense litigation, liability reform, and counseling in the prevention of liability exposure. He has served on the adjunct faculty of The American University's Washington College of Law and is a member of The American Law Institute.

Mr. Behrens has been listed as one of Washington, D.C.'s "top lawyers" by *Washingtonian* magazine. He has published numerous articles on tort and civil justice issues in leading national journals, including the *Harvard Journal on Legislation*, *Cornell Journal of Law and Public Policy*, and *Texas Review of Law & Politics*. Business Insurance named him to its 2004 "40 Under 40" list. He is a recipient of a Burton Award for Legal Achievement and has received an award from several national organizations for major research contributing to civil justice issues. Mr. Behrens has been quoted in publications such as *The Washington Post*, *The Wall Street Journal*, *The New York Times*, and the *National Law Journal*. He has appeared on radio and television, including CNBC, MSNBC, Bloomberg, CNN, Fox Morning News, and C-Span. *The Insider Guide to Public Policy Experts and Organizations* lists him as an expert in the fields of tort and liability reform and the judiciary. He has the highest ratings for Legal Ability and General Ethical Standards under the Martindale-Hubbell Peer Review Ratings system. Mr. Behrens is a member of the Product Liability Advisory Council, Inc., counsel to the Coalition for Litigation Justice, Inc., co-counsel to the American Tort Reform Association, co-chair of the Tort and Product Liability Subcommittee of the Federalist Society's Litigation Practice Group, Advisor to the American Legislative Exchange Council's Civil Justice Task Force, and a member of the Washington Legal Foundation's Legal Policy Advisory Board. Mr. Behrens received his J.D. from Vanderbilt University Law School in 1990. He was a member of the Vanderbilt Law Review and received an American Jurisprudence Award for achievement in tort law. He received a B.A. in Economics from the University of Wisconsin-Madison in 1987.

JOHN MALCOLM (Copyright): John G. Malcolm is an honors graduate from Columbia College and Harvard Law School, who clerked for federal judges in the Northern District of Georgia and on the Eleventh Circuit Court of Appeals. From 1990 to 1997, Mr. Malcolm served as an Assistant United States Attorney in Atlanta, Georgia, where he was assigned to the fraud and public corruption section, and as an Associate Independent Counsel in Washington, D.C., where he investigated fraud and abuse at the Department of Housing and Urban Development. Mr. Malcolm received numerous awards, including the Director's Award for Superior Performance by an Assistant United States Attorney. Between 1997 and August 2001, Mr. Malcolm was a partner at the Atlanta law firm of Malcolm & Schroeder, LLP.

From August 2001 until March 2004, Mr. Malcolm was a Deputy Assistant Attorney General in the Criminal Division of the Department of Justice, where his duties included overseeing the Computer Crime and Intellectual Property Section, the Child Exploitation and Obscenity Section, the Domestic Security Section, and the Office of Special Investigations. From March 2004 until October 2009, Mr. Malcolm was an Executive Vice President and Director of Worldwide Anti-Piracy Operations for the Motion Picture Association of America. Mr. Malcolm has testified over a dozen times before Congress on a variety of topics and has extensive media experience including appearing on or being cited by 60 Minutes, Good Morning America, NPR, CNN, *The New York Times*, *The Wall Street Journal*, *The Washington Post*, *The Los Angeles Times*, and *Newsweek*, as well as dozens of other international media outlets.

NEW ADJUNCT FACULTY MEMBERS

AMIR BOOZARI (Islamic Law): Amirhassan Boozari served as an adjunct professor at UCLA School of Law (2009-2010) where he taught Islamic Law, Constitutionalism & Democracy in Iran (Fall semester), and co-taught Introduction to Islamic Law (Spring 2009) and Political Crimes and Legal Systems (Spring 2010) with Professor Abou El Fadl. He also supervised a number of Ph.D., LL.M and J.D. students' research and writings on Comparative Constitutionalism, Iranian Legal Studies, and Islamic Law. Prior to UCLA, Boozari served as an adjunct professor at David N. Meyers University in the Paralegal Department from 2003-04, where, as a member of a working group of five professors, he participated in planning two major programs on 'International Relations' and 'International Business' for graduate students. Before residing in the United States, Boozari was Legal Advisor to a Parliamentary Commission in Iran's Islamic Consultative Assembly (Parliament), which was charged with the duties of Constitutional Ombudsman in Tehran, Iran from 1990-92. Then, he represented a diverse group of clients in a variety of cases at all levels in Iranian courts, and was Director and Supervisor of his firm (Boozari & Associates) from 1993-2002 in Tehran. Boozari's main areas of research are: Comparative Constitutionalism, Islamic law, International Human Rights, and Democratic Transition in Muslim countries. His dissertation was on "Constitutionalism in Iran" and is going to be published by Palgrave Macmillan. His article on "Islamic Philosophy of Law" will be published in *UCLA Journal of Islamic and Near Eastern Law*, August 2010.

LISA BRACKELMANNS (Juvenile Law): Lisa Brackelmanns-Wilder has practiced as a criminal defense attorney in the Los Angeles County Public Defender's Office for the past twenty years. As a Deputy Public Defender, Ms. Brackelmanns-Wilder spent 12 years as an expert advocating for juveniles in delinquency court. In 2008 she received the Juvenile Attorney of the Year award from the Los Angeles County Public Defender's Association. She has a Bachelor of Arts Degree from University of California at Los Angeles, a Juris Doctor Degree from Loyola Law School and a Master of Philosophy from the Institute of Criminology, Cambridge University.

DANIEL DEWALT (Legal Environment of Non-Profit Organizations): Daniel J. DeWalt is a partner of Goff & DeWalt, LLP, emphasizing construction defect litigation, condominium law, and non-profit association law. Mr. DeWalt earned a Bachelor of Arts degree from California State University in Psychology and Philosophy, a Master of Divinity degree from Princeton Theological Seminary and a Master's degree in Marriage and Family Therapy from Pacific Lutheran University. In addition, Mr. DeWalt earned his Juris Doctor, graduating Magna Cum Laude, from California Western School of Law. Mr. DeWalt is admitted to practice before all the Courts in Washington State and the Federal District Courts for the Western District of Washington. He is the Vice President of Restore International, a non-profit organization working for justice for children and the poorest of the poor in Uganda and the pastor of Harborview Fellowship, an evangelical church in Gig Harbor, Washington.

ANDY FOX (Negotiation Theory and Practice): Chief Andrew P. Fox is the Deputy Fire Chief of Los Angeles Fire Department. Chief Fox has served the City of Los Angeles for 30 years. During his career Chief Fox has been elected to represent both labor organizations representing rank and file members as President of the United Firefighters of Los Angeles City, Local 112 AFL-CIO and management and command staff as President of the Chief Officers Association. Chief Fox earned his B. A. in Political Science from California Lutheran University, and holds a Masters Degree from Straus Institute of Dispute Resolution at Pepperdine University, School of Law. Additionally he is a graduate of Harvard University's John F. Kennedy School of Government and is an adjunct instructor at the National Fire Academy. In addition to his Fire Service career and related organizations, Andrew Fox has served his community as Mayor and Council member for the City of Thousand Oaks for over 15 years. In 2003, Mr. Fox was appointed and has served on the Los Angeles Superior Courts mediation panel. He has been a member of the Board of Directors for the California League of Cities, Los Angeles County Federation of Labor, Southern California Area of Governments, and has chaired the Ventura County Fire Department Strategic Plan Committee.

ROBERT GOFF (Legal Environment of Non-Profit Organizations): Bob Goff is the managing partner of Goff & DeWalt LLP, a construction defect and non-profit association law firm. He is the Founder and President of Restore International, a global non-profit organization created to address human rights injustices. He also serves as the Honorable Consul for the Republic of Uganda, and periodically works with the Judiciary in Uganda. Mr. Goff received his undergraduate degree from San Diego State University and his Juris Doctor Degree from the University of San Diego. He is licensed to practice law in California, Washington, and Nevada. He has authored the book *Finding Karishma* which traces one of his many experiences in fighting for justice for children around the world. Mr. Goff is also a frequent speaker at law schools, universities and churches around the country.

JAMES R. GRIFFIN (Current Issues in Corporate Law): James Griffin is a partner in the Dallas office of the international law firm of Fulbright & Jaworski L.L.P., and is a member of the Firm's Mergers and Acquisitions Practice Group. Mr. Griffin is a corporate attorney specializing in mergers and acquisitions, and in particular, transactions involving public companies. In that connection, he has extensive experience in advising public company boards and special committees in structuring and negotiating public company buy-side and sell-side transactions, defensive strategies, tender offers, leveraged buyouts and going private transactions, as well as with respect to the board's fiduciary duties in such contexts. Mr. Griffin also has extensive experience in structuring, negotiating and advising clients on a wide variety of other acquisition and disposition transactions and related matters, including stock and asset transactions and divestitures. He also serves as Co-Chair of the Firm's Corporate Governance Practice Group.

As an active member of the American Bar Association's Mergers & Acquisitions Committee, Mr. Griffin serves as the Co-Chair of that Committee's M&A Market Trends Subcommittee and as the Vice Chair of that Committee's Subcommittee on Public Company Acquisitions. Mr. Griffin also served as the Project Chair for the 2008 and 2009 Strategic Buyer/Public Company Target Deal Points Study, a highly regarded study of transactional deal points published by the Mergers & Acquisitions Committee. He also advises companies in public and private offerings of securities, including initial public offerings, primary and secondary public

offerings, 144A debt offerings, exchange offers and private placements, and serves on the ABA Committee on the Federal Regulation of Securities. Mr. Griffin is listed in *The International Who's Who of Mergers & Acquisitions Lawyers* and in *The Best Lawyers in America*. He has also been named by his peers as a Texas Rising Star in mergers and acquisitions and corporate finance. Mr. Griffin is a frequent speaker on M&A and corporate governance topics.

DON PHILBIN (Selected Issues in Dispute Resolution: Employment): Don Philbin is an AV-rated attorney-mediator, negotiation consultant and trainer, and arbitrator. He has resolved disputes and crafted deals for more than 20 years as a commercial litigator, general counsel, and president of communications and technology-related companies. Mr. Philbin has mediated hundreds of matters in a wide variety of substantive areas and serves as an arbitrator on several panels, including CPR's Panels of Distinguished Neutrals. He guest lectures at other law schools, is Chair of the ABA Dispute Resolution Section's Negotiation Committee, and is a member of the ADR Section Council of the State Bar of Texas. Mr. Philbin is a Fellow of the American Academy of Civil Trial Mediators and is listed in *The Best Lawyers In America (Dispute Resolution)*, *Super Lawyers*, *The Best Lawyers in San Antonio*, and *The Bar Register of Preeminent Lawyers*.

WILL PRYOR (Arbitration Practice and Advocacy): Will Pryor has convened over 3,000 mediations and arbitrations as a full-time neutral in Dallas, Texas. A graduate of Yale University and Harvard Law School, Mr. Pryor is a former trial lawyer, judge, and First Assistant Attorney General of the State of Texas. He is the author of the *Annual Survey of Texas Law: Alternative Dispute Resolution*, published every summer by the *SMU Law Review*. For many years Mr. Pryor has been an Adjunct Instructor in Alternative Dispute Resolution at the Dedman School of Law at Southern Methodist University. He received his formal training as a neutral at the Center for Public Policy Dispute Resolution at the University of Texas School of Law, as well as in courses sponsored by the Straus Institute and the American Arbitration Association.

CHIEF JUSTICE MYRON T. STEELE (Current Issues in Corporate Law): The Honorable Myron T. Steele is the Chief Justice of the Supreme Court of Delaware. Previously, he served as a Vice Chancellor of the Delaware Court of Chancery. He has presided over major corporate litigation, LLC and limited partner governance disputes and writes frequently on issues of corporate document interpretation and corporate governance. Chief Justice Steele has published over 300 opinions resolving disputes among members of limited liability companies, and limited partnerships, and between shareholders and management of both publicly traded and close corporations. His thesis for the LL.M. degree, *Judicial Scrutiny of Fiduciary Duties in Delaware Limited Partnerships and Limited Liability Companies*, focused on the application of common law fiduciary duties within the contractual framework of alternative business organizations. It was published in the *Delaware Journal of Corporate Law* (32 DEL. J. CORP. L. 1 (2007)). The November 2005 issue of *The Business Lawyer* included an article he co-authored with Sean J. Griffith entitled *On Corporate Law Federalism: Threatening the Thaumatrope* (61 BUS. LAW. 1 (2005)). He co-authored an article with J.W. Verret entitled *Delaware's Guidance: Ensuring Equity for the Modern Witenagemot* published in the Fall 2007 issue of the *Virginia Law & Business Review* (2 VA. L. & BUS. REV. 188 (2007)). That article formed the basis for a keynote speech to the Business Section at the 2007 ABA Annual Meeting. Chief Justice Steele served as Adjunct Professor of Law at Penn Law to co-teach "Advising the Board of Directors," He also taught a short course entitled "Advising the Board of Directors in a Mergers and Acquisitions World" at the University of Virginia Law School during the Spring of 2010.

The Directorship Magazine ranked Chief Justice Steele as one of the 100 most influential people in corporate governance in the United States. Ethisphere Magazine ranked Chief Justice Steele second in its list of "the 100 Most Influential People in Business Ethics for 2007." Lawdragon Magazine has consistently placed Chief Justice Steele among its annual Lawdragon 500 "Leading Lawyers in America" and "Top Judges in America."

MARK TRAVIS (Selected Issues in Dispute Resolution: Employment): Mr. Travis practiced labor and employment law for 25 years before becoming a full-time neutral in 2008, and in October 2009 became Director of the Tennessee Labor-Management Center. He is a graduate of the University of Louisville School of Law and received his LL.M. in Dispute Resolution from the Straus Institute in 2007. Mr. Travis currently serves on the panels of the American Arbitration Association, the Equal Employment Opportunity Commission, the International Mediation Institute, the Nuclear Regulatory Commission, and the Financial Industry Regulatory Authority. He has also been appointed to serve as an administrative law judge for the United States Equal Employment Opportunity Commission. Mr. Travis has served as chair of the Dispute Resolution Section of the Tennessee Bar Association, is a founding member of the Tennessee Association of Professional Mediators and the Tennessee Academy of Mediators and Arbitrators, and is listed on CPR's Employment Panel of Distinguished Neutrals. He is also an adjunct professor of labor and employment law at Tennessee Technological University.

ROBERT UHL (Arbitration in the Securities Industry) Mr. Uhl sits as an NASD arbitrator and is a member of the Public Investors Arbitration Bar Association (PIABA). Mr. Uhl has appeared on Fox News and has been quoted on securities matters by the Wall Street Journal, Registered Representative magazine, CBS Marketwatch and by other members of the national and local press. Mr. Uhl was recognized as a 2005, 2006, 2007, 2008, 2009 and 2010 Southern California Super Lawyer. He was on the Dean's List and a Member of the Law Review at Fordham University. In 2010, Mr. Uhl was appointed as the first Director of the Pepperdine University School of Law Investor Clinic which received a grant from the Financial Industry Regulatory Authority (FINRA) to establish the clinic. In addition, Mr. Uhl has been appointed as an adjunct professor at the Pepperdine University School of Law where he will teach a course on securities arbitration. He is also a member of the Council of Distinguished Advisors of the Straus Institute of Pepperdine University School of Law.

SCOTT VAN SOYE (Alternate Dispute Resolution): Scott Van Soye has been a civil litigator and judicial staff attorney for over 20 years. He currently heads the mediation practice at the downtown Los Angeles law firm of Kane, Ballmer & Berkman. He also continues his varied litigation practice, representing public entities in eminent domain, affordable housing and redevelopment cases, and serving as counsel in trademark, insurance, and employment disputes. Professor Van Soye has mediated numerous matters for private clients, the Equal Employment Opportunity Commission, the San Bernardino County Superior Court, and the Fourth District Court of Appeal. Professor Van Soye graduated with honors from the University of California, Irvine with degrees in Political Science and Social Ecology. He received his JD degree from UCLA and an LL.M in Dispute Resolution from the Straus Institute at Pepperdine University. He has often acted as a speaker and panelist on topics relating to both dispute resolution and the Americans with Disabilities Act (ADA). and has lectured at the John Greenleaf Whittier School of Law on the overlap between the ADA and workers' compensation. He has published several articles on alternative dispute resolution, including "Illusory Ethics: Legal Barriers to an Ombudsman's Compliance with Accepted Ethical Standards" 8 *Pepperdine Dispute Resolution Law Journal* 117, which has been cited by several standard works. He has also served as a *pro-tem* judge.

NEW COURSES BEING OFFERED THIS FALL 2010

ADMIRALTY & MARITIME LAW: This course surveys the substantive and procedural aspects of maritime law in the United States. Topics include maritime jurisdiction, choice of law, carriage of goods by sea, charter parties, tort, collision, maritime liens, and salvage. Additional optional topics may include an introduction to international law of the sea and piracy.

ADVANCED PROPERTY ISSUES: Advanced Property Issues is a two credit seminar. The classroom component will examine (1) the different theoretical underpinnings of the law of Property, and (2) a select number of Property topics to be determined in greater depth. 'Property' as used in this class will be defined broadly, so one can expect to study or write on virtually any Property related topic, from first year Property, to Trusts & Estates, to the Takings Clause, to Land Use Regulation, to Sustainable Development. In addition, Professor Beate Gsell from the University of Augsburg will co-teach four of the classes so the class will have a comparative law component as well. Students will be required to write a paper of publishable quality, at least 25 pages long, on a topic of their choosing. There will not be an exam. The course will fulfill the upper division writing requirement.

APPELLATE ADVOCACY: This course has the twin objectives of providing intensive instruction in appellate brief writing as well as the study of the methods and procedures used in appellate oral advocacy. Students will draft an appellate brief and will participate in an appellate argument in a moot court setting. This course must be taken by all Interschool Moot Court Competition Team members, but is also open to students who are not on the Team or otherwise involved with Moot Court.

ARBITRATION LAW IN THE SECURITIES INDUSTRY: This class will examine arbitration law, practice and advocacy skills within the context of investor disputes. The course will focus both on procedural rules that govern securities arbitration as well as the substantive law underlying securities arbitration. The course will also emphasize the practical aspects of securities arbitration including case evaluation, FINRA rules, historical and current common claims against brokerage firms, defenses raised by brokerage firms, selection of arbitrators and practical advice on filing cases. In addition, the course will emphasize current trends in securities arbitration law. This course is a pre-requisite to a student's invitation to participate in the Investor Advocacy Clinic, which will be offered in the Spring semester. Each year, six 2L students from this class will be invited to participate in the Investor Advocacy Clinic.

Note: Students who take Arbitration Law in the Securities Industry are not eligible to receive credit for taking Law 1672 Arbitration Law.

CURRENT ISSUES IN CORPORATE LAW: This course will examine some of the issues corporate boards confront when considering M&A transactions, including (i) addressing board and management conflicts, (ii) selecting financial and legal advisors, (iii) establishing an appropriate sales process, (iv) preparing for and responding to hostile bidders, (v) negotiating deal protection measures, and (vi) anticipating possible litigation, and will discuss the nature of the advice that counsel should provide a board in each context.

ENVIRONMENTAL SUSTAINABILITY LAW SEMINAR: This seminar course introduces the concept of environmental sustainability as reflected in the study of climate change law, natural resources and energy law, land use planning, development, and transportation law, pollution control, food supply, and disaster law. Students will be introduced to sustainability concepts within an international context and will explore local, national and international approaches to addressing sustainability concerns. In this seminar course, students

will select a specific topic, with the approval and guidance of the professor, and write and present a paper. The course will fulfill the upper division writing requirement.

LEGAL ENVIRONMENT OF NON-PROFIT ORGANIZATIONS: This course is designed to survey the legal structure of nonprofit organizations from both state and federal law perspectives. Attorneys working in this field are faced with many complex issues in navigating the laws governing such organizations. The broad range subject material will make for interesting research and discussion, and will be of practical use to the student in the future by achieving familiarity with the laws surrounding an increasingly expanding field.

NATIONAL SECURITY LAW: This course examines international and U.S. law relevant to the handling of national security matters. On the domestic level, we will study the allocation of power under the Constitution between Congress and the President with respect to war powers and we will assess the role of the courts as a check on the political branches in this area, particularly as it relates to ongoing efforts to fight terrorism. Key legal issues related to the detention and trial of suspected terrorists, including recourse to U.S. courts and the use of military commissions, will be examined. On the international level, the course focuses on international law governing the use of force and conflict management, including an introduction to the problem of war crimes and a review of the U.N. Charter framework for collective efforts to maintain international peace and security. The course concludes by examining selected disarmament and arms control problems, particularly those presented by the proliferation of nuclear weapons.
