4/1		GARY HAUGEN (Human Rights and the Rule of Law in the Developing World): Gary Haugen, President and CEO of the International Justice Mission, will teach a 1-unit seminar on Human Rights and the Rule of Law in the Developing World. Mr. Haugen has extensive experience in the fields of human rights and rule of law. He served with the U.S. Department of Justice and the United Nations, during which time he investigated the Rwandan genocide. Mr. Haugen later founded the International Justice Mission, an international human rights agency that rescues victims of violence, sexual exploitation, slavery, and oppression worldwide. Mr. Haugen's most recent work focuses on the enforcement of law as the new mandate for human rights. He wrote a recent article on the topic that was featured in <i>International Affairs</i> . Mr. Haugen's seminar will make an in-depth exploration into the enforcement of human rights with a particularly emphasis on working with local government agencies and communities to provide effective access to justice.

1/7	<p>JACK BEARD (International Public Law): Jack Beard is a Professorial Lecturer at the UCLA School of Law where he has taught since 2005 and where the graduating class of 2008 elected him Professor of the Year. Professor Beard received his B.S.F.S, magna cum laude, from Georgetown University, his J.D. magna cum laude, from the University of Michigan, and his LL.M. in International and Comparative Law, from Georgetown Law. From 1990 to 2004, he served as Associate Deputy General Counsel (International Affairs), Office of the Secretary of Defense, and was responsible for legal matters related to international defense cooperation, status of forces issues, nuclear nonproliferation activities, and programs assisting states in the dismantlement of weapons of mass destruction. He served as the senior legal adviser on U.S. Government delegations negotiating numerous international agreements with states in the former Soviet Union and the Middle East. Prior to joining the Office of General Counsel in 1990, he held several positions in government and was also previously engaged in private law practice in Washington, D.C. As an adjunct professor, he received awards for his teaching at both Georgetown Law and the Johns Hopkins School of Advanced International Studies. Professor Beard has written articles on international law and the use of force, the law of war, terrorism, and international efforts to prevent the proliferation of weapons of mass destruction.</p>

The Certificate in International and Comparative Law offers students the opportunity for exposure to different facets of international law and international living in order to better position them for an international career. The certificate seeks to encourage students to expand their career goals by facilitating overseas experiences in one of the Semester or Summer overseas programs in London, Copenhagen, Augsburg, Rwanda and Uganda. Students will be mentored by the international faculty through international courses, internships, moots and memberships as well as the initial application interview. Although not required, students are encouraged to develop language skills and direction is given to help achieve this. In order to complete the certificate, students are required to attend at least one of the overseas programs and complete 14 units of required and elective courses.

D & L STRAUS DISTINGUISHED VISITING PROFESSOR

PAUL L. CARON (Federal Income Taxation and Federal Estate and Gift Taxation): Paul L. Caron is Associate Dean of Faculty and Charles Hartsock Professor of Law at University of Cincinnati College of Law. He is one of the leading entrepreneurial tax scholars in the country. Since joining the University of Cincinnati faculty in 1990, he has written numerous books and law review articles, and is active in a variety of scholarly projects. Dean Caron's most recent books include *Tax Stories* (Foundation Press, 2d ed. 2009) and *Federal Wealth Transfer Taxation: Cases and Materials* (Foundation Press, 6th ed. 2009) (with Paul McDaniel & Jim Repetti). His most recent law review articles concern the estate tax, law school rankings and the impact of new technologies on legal scholarship and teaching. He serves as Series Editor for Foundation Press in developing a Law Stories Series of books patterned after his *Tax Stories* book. In addition, he is the Publisher and Editor of TaxProf Blog, the most popular tax blog on the Internet. He is the Publisher and Editor-in-Chief of the Law Professor Blogs Network of more than 50 blogs edited by law professors around the country in other areas of law. Dean Caron has served as a visiting professor at the University of Florida College of Law, Florida State University College of Law, University of San Diego School of Law, and New York University/IRS Office of Chief Counsel Continuing Professional Education Program.

DISTINGUISHED VISITING PRACTITIONER IN GLOBAL JUSTICE

GARY HAUGEN (Human Rights and the Rule of Law in the Developing World): Gary Haugen, President and CEO of the International Justice Mission, will teach a 1-unit seminar on Human Rights and the Rule of Law in the Developing World. Mr. Haugen has extensive experience in the fields of human rights and rule of law. He served with the U.S. Department of Justice and the United Nations, during which time he investigated the Rwandan genocide. Mr. Haugen later founded the International Justice Mission, an international human rights agency that rescues victims of violence, sexual exploitation, slavery, and oppression worldwide. Mr. Haugen's most recent work focuses on the enforcement of law as the new mandate for human rights. He wrote a recent article on the topic that was featured in *International Affairs*. Mr. Haugen's seminar will make an in-depth exploration into the enforcement of human rights with a particularly emphasis on working with local government agencies and communities to provide effective access to justice.

VISITING PROFESSOR

KHRISTA MCCARDEN (International Tax and Federal Taxation of Business Entities): Before joining Pepperdine, Professor McCarden practiced with Morgan Lewis in London where she focused on all aspects of international taxation, including corporate, individual, estate, and trust planning for U.S. persons conducting business or residing abroad. She also advised individuals and charities on U.S. and cross-border charitable giving and structuring and served as Pro Bono Vice Chair for the office. Professor McCarden has published articles in the United States and in the United Kingdom and regularly presented lectures on US/UK dual-qualified charitable structures. While living in London, Professor McCarden was actively involved with her local church and with several charitable organizations. In addition, she was appointed to the Board of the Harvard Law School Alumni Association of the UK.

Professor McCarden began her legal career with Latham & Watkins LLP in Los Angeles. During her first two years of practice, she was selected as a Washington, D.C. delegate by the State Bar of California and the Los Angeles County Bar Association Taxation sections to present a policy paper on charitable giving and planning before the Internal Revenue Service and the Treasury Department, which was later published. She has practiced international tax law in Paris and completed a clerkship in New York with Judge Barrington D. Parker of the U.S. Court of Appeals for the Second Circuit. Professor McCarden has published articles in the United States and in the United Kingdom and regularly presented lectures on US/UK dual-qualified structures.

ROBERT BRAIN (Commercial Law-Sales): Robert Brain has a B.S. in Biology and an M.S. in Biochemistry from Stanford University. His law degree is from Boalt Hall School of Law. He began his legal career in the litigation department of Gibson, Dunn & Crutcher, where he received a pro bono award from the LA County Bar Association for his work with Public Counsel, and represented the ACLU in a case before the United States Supreme Court. He has tried cases on a volunteer basis for the LA District Attorney's Office and has served as a commercial arbitrator for the American Arbitration Association. Professor Brain taught at both Pepperdine University School of Law and McGeorge School of Law before becoming a partner at the litigation firm of Howarth & Smith where he tried fraud, defamation, securities, products liability and assault matters, representing diverse clients such as the Republic of the Marshall Islands, Suzuki Motor Corporation and the victims of 9/11. He joined the faculty of Loyola Law School Los Angeles in 2006, where he teaches Sales, Contracts, Ethical Lawyering and Legal Writing. He has published articles in evidence and commercial law, is the author of SUM AND SUBSTANCE OF CONTRACTS, and is a co-author of COMPUTER AND VIDEO GAME LAW: CASES, STATUTES, FORMS, PROBLEMS & MATERIALS, currently the only casebook on video game law used in American law schools.

DISTINGUISHED VISITING PRACTITIONERS IN RESIDENCE

ROGER COSSACK (Media and the Law): Roger Cossack was a prosecutor and a defense lawyer during his 22 years of practice and in 1984 he argued *U.S. v. Leon* before the U.S. Supreme Court. Prior to beginning his private practice of law he served on the faculty of the UCLA Law School. In 1994 he joined CNN as the co-host of their award winning legal show Burden of Proof and also was the CNN legal analyst. From 1994 to 2001 he covered all of the major U.S. legal events including breaking the *Bush v. Gore* decision, the impeachment of President Clinton, and the disputed election of 2000. Since 2002 he has served as the legal analyst for ESPN, reporting on how the law applies in various ways to sports.

DISTINGUISHED VISITING PROFESSORIAL LECTURER

JACK BEARD (International Public Law): Jack Beard is a Professorial Lecturer at the UCLA School of Law where he has taught since 2005 and where the graduating class of 2008 elected him Professor of the Year. Professor Beard received his B.S.F.S, magna cum laude, from Georgetown University, his J.D. magna cum laude, from the University of Michigan, and his LL.M. in International and Comparative Law, from Georgetown Law. From 1990 to 2004, he served as Associate Deputy General Counsel (International Affairs), Office of the Secretary of Defense, and was responsible for legal matters related to international defense cooperation, status of forces issues, nuclear nonproliferation activities, and programs assisting states in the dismantlement of weapons of mass destruction. He served as the senior legal adviser on U.S. Government delegations negotiating numerous international agreements with states in the former Soviet Union and the Middle East. Prior to joining the Office of General Counsel in 1990, he held several positions in government and was also previously engaged in private law practice in Washington, D.C. As an adjunct professor, he received awards for his teaching at both Georgetown Law and the Johns Hopkins School of Advanced International Studies. Professor Beard has written articles on international law and the use of force, the law of war, terrorism, and international efforts to prevent the proliferation of weapons of mass destruction.

NEW ADJUNCT FACULTY MEMBER

ROBERT GUMER (Licensing): Robert Gumer is Senior Vice President of APA Talent & Literary Agency in Beverly Hills. He specializes in the representation of writers and producers of series television. Among the shows his clients have created and/or executive produced are XENA, WARRIOR PRINCESS, ANGEL, DESPERATE HOUSEWIVES and FAMILY GUY. Prior to joining APA, Mr. Gumer was President of the Kaplan Stahler Gumer Braun Agency and a literary agent at International Creative Management (ICM). A graduate of Brown University and NYU Law School, he started his career as an associate at the New York entertainment law firm Barovick Konecky and then joined the Los Angeles firm Sanders, Barnet & Goldsmith. Before becoming a literary agent, Mr. Gumer served as an executive at Columbia Pictures Television, first as Director of Business Affairs and then as Director of Comedy Development.

KENNETH LEE (Complex Litigation): Ken Lee is a litigation partner at the Los Angeles office of Jenner & Block LLP. Prior to joining Jenner, he served as an Associate Counsel to President George W. Bush and also worked as Special Counsel to the U.S. Senate Judiciary Committee. Ken began his career at Wachtell, Lipton, Rosen & Katz in New York, and clerked for the Honorable Emilio M. Garza of the U.S. Court of Appeals for the Fifth Circuit. He is a graduate of Cornell University and the Harvard Law School.

JAY MILBRANDT (Social Entrepreneurship): Director, Global Justice Program Interim Associate Director, Herbert & Elinor Nootbaar Institute on Law, Religion and Ethics. As director of the Global Justice Program, Jay Milbrandt organizes the law school's justice-seeking work in Africa, Asia, and Latin America. Through the Nootbaar Institute, he helps coordinate and organize conferences, speakers, and local student service activities. Jay is an alumnus of the School of Law and the Graziadio School, earning joint degrees in law and business, as well as a certification from the Geoffrey H. Palmer Center for Entrepreneurship and Law.

BRIAN J. PHILPOTT (Trademarks, Unfair Competition and Unfair Trade Practices): Brian J. Philpott is a Senior Attorney at Koppel Patrick Heybl & Dawson, a boutique intellectual property law firm located in Westlake Village, California. His previous legal experience includes positions with Secret Hill & Butler in Tulsa, Oklahoma, Blakely Sokoloff Taylor & Zafman in Los Angeles, and Hammonds in London. While in London, Brian published several articles, including contributions to the Hammonds Reporter and the Institute of Trade Mark Attorneys monthly journal. His current practice focuses on trademark and copyright matters, patent prosecution and litigation, and general international intellectual property issues. He has prosecuted and litigated several trademark matters before California state and federal courts and the United States Patent and Trademark Office. Mr. Philpott earned a Bachelor of Science in Electrical Engineering from Oklahoma State University and is an alumnus of the School of Law. He is a Fellow of the Geoffrey H. Palmer Center for Entrepreneurship and Law and a contributing author to *The Ninth*, a blog following trends in the Ninth Circuit Court of Appeals.

CAROLYN SCHENCK (Honors Appellate Advocacy): Carolyn Schenck is a Senior Attorney with the Office of Chief Counsel for the Internal Revenue Service in Los Angeles. Ms. Schenck has litigated hundreds of cases on behalf of the IRS in U.S. Tax Court. She also assists the Department of Justice in cases involving injunctions and abusive tax return preparers/promoters. Prior to joining the IRS, Ms. Schenck was an Attorney for the Securities and Exchange Commission, Division of Enforcement. She also worked for Chief Judge Alex Kozinski of the Ninth Circuit and Judge H. Robert Mayer of the Federal Circuit Courts of Appeals. Before her law career, Ms. Schenck worked for U.S. Senator John McCain on his 2000 presidential campaign and as a weapons analyst for the Department of Defense. She is a graduate of Northern Arizona University and Pepperdine Law School.

NEW COURSES BEING OFFERED THIS SPRING 2011

ADVANCED LITIGATION WRITING: This course is designed to provide students with exposure to and experience with drafting a wide variety of documents required in litigation. For example, students will draft and review demand letters to opposing counsel, pleadings, discovery documents, declarations, separate statements in support of summary judgment motions, argument sections for procedural motions, and in limine motions. Students will be assigned to represent either the plaintiff or the defendant in a civil case and will alternate each week drafting documents to be served on the opposing side. The substantive law needed for completing the document drafting will be given to students in a closed library format. This class is intended to supplement the first-year Legal Research and Writing course by exposing students to a broader array of drafting assignments. It is particularly intended for those with an interest in litigation. Classroom instruction will focus on the purpose of the various types of documents students will be drafting and how they fit into the litigation process. The course meets every week for a two-hour session, during which students will receive classroom instruction, review and critique other students' work, and perform in-class exercises. Enrollment will be limited to twelve students and interested students should submit a one-page memorandum to the professor explaining why they want to take the course. This memorandum should be supplied to the professor before the student enrolls in the course. This course provides an opportunity for fulfilling the upper-division writing requirement.

BIBLE AND THE LAW SEMINAR: This seminar will give students who are seriously interested in the relationship between the Bible and the law the chance to be exposed to some well-known scholars in the fields of law and theology as they wrestle with the course topic. The course will be built around a book project by those scholars. The book will examine both how Christians have historically looked at what various sections of the scriptures teach about positive law and what those scriptures might teach us today. The focus will be on the positive law—the law that is adopted and enforced by governments, rather than the moral law. Each chapter of the book will focus on a different section of scripture and is being co-authored by a law professor and a theologian. Author/speakers include David Van Drunen (Westminster Seminary, CA), Randy Beck (University of Georgia), David Skeel (University of Pennsylvania), Tremper Longman (Westmont College), William Brewbaker (University of Alabama), Phillip Long (Regent College, Vancouver), John Witte (Emory), Barbara Armacost (University of Virginia), Peter Enns (Westminster Seminary, PA, retired), Dallas Willard (USC), Joel Nichols (St. Thomas, MN), and John Nagle (Notre Dame).

COMMUNITY OUTREACH: YOUTH MENTORING IN LAW: This two-unit course includes both an on-campus classroom component and an off-campus community outreach component. The on-campus sessions will begin with an introduction to the basics of community outreach work in underprivileged communities and strategies for teaching and mentoring youth. Subsequent sessions will focus on particular teaching exercises designed to introduce high school students to the legal system, the basics of criminal, civil and constitutional law and the skills of oral advocacy and alternative dispute resolution. The off-campus outreach component entails conducting teaching exercises and mentoring sessions with the selected students from the Law and Social Justice Academy at Jordan High School in Watts, California, as well as attending social activities with the mentees. Law students will be responsible for their own transportation to and from the Jordan campus, which is approximately 35 miles from the Malibu campus. These off-campus sessions will occur every other week, usually on Thursday afternoons and will be approximately two hours in duration, not including travel time. The Jordan students will be brought to the Malibu campus for several sessions during the semester and there will be other off-campus social activities at other locations as well.

HUMAN RIGHTS AND THE RULE OF LAW IN THE DEVELOPING WORLD: Human Rights and the Rule of Law in the Developing World seminar will make an in-depth exploration into the enforcement of human rights with a particularly emphasis on working with local government agencies and communities to provide effective access to justice. This 1-unit seminar will culminate with a paper on this topic.

LAW AND SEXUAL ETHICS: This course will explore the ethics and law pertaining to the regulation of sexuality. The course will deal first with historical and philosophical approaches to sexuality. It will then explore a series of major legal and political issues, including sexual expression, reproduction, surrogacy, regulation of consensual and non-consensual sexual relations, and various issues surrounding sexual orientation. The nature of the class requires a cross-cutting analysis of numerous legal disciplines, including constitutional law, criminal law, international and comparative law, contract law, tort law, and family law.
