

LCLD develops action programs designed to help a new and more diverse generation of attorneys ascend to positions of leadership.

In that position, he also served on the Los Angeles County Bar Association's Executive Committee and Board of Trustees. He is also secretary of the American Bar Association's Council of Appellate Lawyers.

Before joining the firm, Mr. Kressel was a litigation associate with Irell & Manella LLP. He also served as a judicial law clerk to the Honorable Jay S. Bybee of the United States Court of Appeals for the Ninth Circuit.
