

PROFESSIONAL SKILLS PROGRAM GROWS IN ATTENDANCE AND EXPANDS LOCATIONS

In June 2014, the 27th Annual Professional Skills Program had record attendance, with 300 participants from 30 states and six foreign countries. The 20 participants from foreign countries were from: Argentina, Austria, Canada, Greece, Singapore, and New Zealand. This year's 28th Annual Professional Skills Program attracted 243 participants from 28 states and four foreign countries: Australia, Canada, Ireland, and Singapore. This comprehensive program has grown to consist of 10 simultaneous courses offered with 18 accomplished scholars and practitioners serving as faculty. Course topics ranged from basic mediation and negotiation skills to more advanced and specialized areas like construction, elder care, and family mediation. The program provides three days of unique educational opportunities for practicing professionals. To provide for personalized instruction, enrollment for each course is limited to ensure a close working relationship among the faculty and participants. Course sessions include lectures, small group discussions, and practice exercises. This synergy of ideas provides a truly unique learning experience.

New Nashville Professional Skills Program October 29–31, 2015

Stipanowich Visits at Heidelberg University as Part of a New Collaborative Relationship for European Students to Earn an LLM in Dispute Resolution from Pepperdine

During the summer of 2015, following Pepperdine's 2014 signing of a Memorandum of Understanding with Heidelberg University, Straus academic director and professor Tom Stipanowich taught in Heidelberg as the Max Kade Visiting Professor at the University Institute for Foreign and Private International and Business Law. His host was Professor Dr. Thomas Pfeiffer. In addition to teaching a course for Heidelberg law students on negotiation theory and practice, Stipanowich delivered a talk at the Heidelberg Center for American Studies on "The Role of ADR in the United States" and conducted a workshop on managing corporate conflict. He lectured on the recognition and enforcement of international arbitration awards under the New York Convention as a part of a course on the law of international dispute settlement in private law. He also participated in a seminar and extended informal discussions with law students and post-doctoral fellows. He observes,



This past year, Pepperdine entered into a formal relationship with Heidelberg University's law school to allow students to transfer 8v units from Heidelberg to Pepperdine's LLM program. Students pursuing this track will have access to the same dispute resolution coursework as traditional full-year students, but they will be able to complete their LLM at Pepperdine with only one semester of residence in Malibu. Last spring, Heidelberg student Slawa Walzenbach began working on her LLM through this collaborative initiative by taking courses in Heidelberg. She was able to take Professor Stipanowich's course when it was offered in Heidelberg this summer, and in Fall 2015, she will attend a full semester of courses in Malibu.



Mediating the Litigated Case Continues to Expand Around the Globe

The Mediating the Litigated Case program is a sophisticated sixday training for experienced litigators, in-house counsel, and other practitioners. Professionals can study the mediation of litigated cases with the aim of becoming a professional mediator or better advocate.

The program meets annually in three locations in California—Malibu, West Los Angeles, and Irvine—and in Washington, D.C. An exciting component has been to offer the program at international locations as well as hosting groups in Malibu from other countries.

The Thailand judiciary is coming to Malibu for the third time in September 2015. Thirty-six judges will be on the Malibu campus for Mediating the Litigated Case, as well as two days of Advanced Mediation training. Highlighting the program will be two days of site visits to the Los Angeles Superior Court, Centinela Youth Services, JAMS, and Asian Pacific Dispute Resolution Center. Graciously hosted by these four organizations, the site visits offer the judges different areas of focus for mediation.

Taking the Mediating the Litigated Case program to other countries offers opportunities for people who might not be able to come to the U.S. In November, in partnership with the Judicial School of the Tribunal Regional do Trabalho da 1ª Região (TRT 1), the program will be offered for the fourth time in beautiful Rio de Janeiro, Brazil. With the introduction of a new law on mediation and a new code of civil procedure, Brazil is undergoing dramatic and significant changes in its judicial system. Mediating the Litigated Case has empowered Brazilian legal professionals with expertise and skills to adapt to this fast-changing reality in an effective and successful way.

A new location for the program will be Singapore on October 8-10 and 12-13, 2015. Co-sponsored by Aequitas Law, LLP, other sponsoring organizations are Harmony Mediation Group, Society of Mediation Professionals (Singapore) and Singapore Mediation Centre. Our host for the program is the Mediation Chambers of the Supreme Court of Singapore. Peter Robinson, managing director of the Straus Institute, and Judge Irwin Joseph will travel to Singapore to conduct the training.

Straus Institute and Pepperdine's Graduate School of Business Management Hosts "Reimagining Corporate Conflict Management" Workshop

On September 17-18, 2014, the Straus Institute for Dispute Resolution and Graziado School of Business Management co-hosted a by-invitation-only, facilitated, interactive workshop designed to address the serious challenges that business organizations face in dealing with conflict, from interpersonal issues in the workplace to high-stakes commercial disputes. "Reimagining Corporate Conflict Management" was intended to explore options that minimize costly conflict escalation, enhance value creation, optimize essential relationships, and align with business objectives and values.

The inspiration for the workshop came from a group of accomplished conflict resolution professionals (including Straus professor Tom Stipanowich and GSBM professor Ann Feyerherm) calling themselves "InnovADR." The group recognized that although companies have long worked to improve and streamline conflict management through various "alternative dispute resolution" methods, those practices have not fully realized their promise to reduce cost and produce results that serve business interests; there remains significant room for improvement. The group therefore designed the workshop as a means of convening business leaders, corporate counsel, and conflict management professionals to discuss integrative approaches aligning emerging best practices in conflict management with corporate objectives and thereby to transform strategic approaches to corporate conflict at all levels.

Stipanowich Named New Zealand Visiting Fellow, Gives Annual Lecture on International Dispute Resolution

Each year, the New Zealand Law Foundation supports a Visiting Fellowship to facilitate an annual Lecture on International Dispute Resolution by a visiting international scholar. The initiative is co-sponsored by the country's two leading law schools (Victoria/ Wellington and Auckland), as well as by the Arbitrators' and Mediators' Institute of New Zealand. In the third year of the program, Professor Stipanowich was invited to be the Visiting Fellow. In addition to delivering the main lecture (twice, in Wellington and Auckland), he gave five other speeches, ranging in topic from mediation and arbitration to a presentation at a local cinema on the subject of Bette Davis, James Cagney, and Olivia de Havilland's battles with Warner Bros. Studios.

The Foreign Direct Investment Moot

In any given year, direct foreign investment disputes involve amounts in controversy totaling many billions of dollars. The Straus Institute at Pepperdine School of Law was among the earliest institutions to offer a regular course devoted to investor-state arbitration, with its distinctive features and many challenges. It was therefore natural that Pepperdine, in 2006, would also be one of the institutions founding the Foreign Direct Investment International Arbitration Moot, a competition that annually brings together dozens of teams from around the world to argue both sides of a timely investor-state case. The Moot has become an important fixture in the international arbitration community as a training ground for arbitration advocates and as a vehicle for examining important questions arising out of investor-state disputes.

On October 24-27, 2014, Pepperdine hosted teams from 30 law schools and a full complement of international arbitrators to judge the rounds. Masters of ceremonies for the event were Professor Jack Coe, Straus faculty director for the LLM in Dispute Resolution International Commercial Arbitration program; FDI Moot director Christian Tyler Campbell; and event manager Manuela Ines Wedam from the Center for International Legal Studies.

For the Straus Institute, the FDI Moot is part of its twin commitments to advance a better understanding of the theory and practice of international dispute settlement and to maintain a vibrant and welcoming place for all in the international commercial arbitration community.

Peter Robinson, Managing Director

The 2014-2015 academic year was a busy one for Peter Robinson.

In addition to serving as managing director for the Straus Institute, he served as the associate dean for finance and administration for the School of Law. He enjoyed this opportunity to assist the dean in navigating the current fiscal challenges in legal education. He was also relieved when the dean found a great person to replace him as associate dean, readily confessing that he was spread so thin that he was not doing a great job in either position. The associate dean position allowed him more than a few opportunities to practice the principles in his apology course.

Robinson served as academic advisor for 75 LLM students, as well as taught both sections of Mediation Theory and Practice and two sections of the Apology, Forgiveness, and Reconciliation courses. He also taught the MLCE workshops for Mediating the Litigated Case in August and February as well as the Professional

Skills Program at Malibu in June and at the University of Maryland in March. He taught Mediating the Litigated Case in Rio de Janeiro and negotiated the ongoing partnership with the Judicial College in Rio de Janeiro. He presented at the ABA's Conference for the Section in Dispute Resolution and off-campus workshops for a variety of entities including the Minnesota Bar's mandatory continuing education office, law schools and courts in Korea, and a mediation conference in Greece.

Since he ceased being associate dean in April, he has been leading an effort to expand Straus' LLM program over the next three years. He is also very much enjoying his first grandchild.

Straus Collaborates with Brazilian Judicial College

After a very successful start in January 2014, the Straus Institute and the Regional Labor/Employment Tribunal continued to strengthen their partnership by presenting the Mediating the Litigated Case at the Judicial Schools in Rio de Janeiro (1st Region) and Salvador (5th Region) in November. The program was attended by about 50 judges in each city, including representatives of the National Council of Justice and other tribunals in the country.

Brazil is undergoing significant changes in its judicial reality as a result of the aggressive governmental incentive towards resolving disputes through mediation, including the introduction of a brand new law of mediation which took effect on June 25, 2015. These developments have made it imperative that local legal professionals become equipped with the necessary knowledge and skills to supply the society with an efficient and appropriate means of resolving disputes that is both compatible with the law and with the socioeconomic reality in the country.

Because of the absolute success of the program taught by professors Peter Robinson, Tracy Allen, Marcelo Rosadilla, Michael Siboni, and Judge Alexander Williams III, the Straus Institute and the Escola Judicial of the Regional Employment Tribunal of the 1st Region — Rio de Janeiro have established a first-of-its-kind partnership to further develop the study of mediation and potential applications by the Brazilian judiciary. The first program stemming this partnership will be held in Rio from November 9 to 13 and is open to all judges, lawyers, and legal professionals from both Brazil and the US.

Lifting Women to Lift the World: Women in Negotiation Academy

Straus launched its first Women in Negotiation Academy, "Creating Sophisticated and Skilled Negotiators," in December 2014. The program was taught by Professor Stephanie Blondell and commercial mediator and adjunct professor Denise Madigan. The academy was inspired by a popular sentiment that empowering women is key to solving many of the world's most challenging problems. Teaching women negotiation skills contributes equally to promoting justice, solving problems, and serving peace.

The training curriculum is divided into two days: Day 1 is "Negotiating for Self"; Day 2 is "Negotiating for Others." On top of the training curriculum, each participant receives individual coaching from leaders in the legal and mediation community in Los Angeles. The feedback during negotiation simulations supports transformation. The program's intent is not for the participants to simply take in knowledge, but to become better, more confident, and skilled in their next negotiations.

The Academy will be offered twice yearly, in Malibu in July and at the Pepperdine West Los Angeles Graduate Campus in December.

Assistant Professor Stephanie Blondell

A day in the life of Assistant Professor Stephanie Blondell could happen anywhere in Los Angeles County. Professor Blondell manages the Mediation Clinic at Pepperdine, which can bring her to the courthouses in Van Nuys, Inglewood, Downey, or Alhambra, California. There she works with students to serve the citizens of Los Angeles in resolving their disputes. This past year, Pepperdine students mediated 1,200 cases for the citizens of Los Angeles.

"Our students have a tremendous impact on their community," says Professor Blondell.

"Watching our students realize that impact is one of the most rewarding aspects of my job.

Professor Blondell is also the academic advisor for all of JD/MDR and Certificate students, and she regularly teaches the Psychology of Conflict Communication course. Professor Blondell also serves as the lead trainer in the Washington, D.C. Mediating the Litigated Case Program, the Mediation Skills for Judges program in Perth, Australia, and the Women in Negotiation Academy.

"Teaching at the law school—specifically participating in academic/career advising—inspired me to teach Women in Negotiation Academy. When I see the struggles that women have with confidence, or with simply seeing the playing field accurately, I wanted to make a difference."

Readers acquainted with Professor Blondell may have also noticed that Professor Blondell changed names this year, from Bell to Blondell. Congratulations to her on her marriage.

Straus' Undergraduate Certificate in Conflict Management – "Coming on Strong!"

The Undergraduate Certificate in Conflict Management (CCM) is a joint enterprise of two highly successful programs, the Straus Institute—recently ranked the top dispute resolution program in the world for the 11th consecutive year-and Seaver College, Pepperdine University's undergraduate college of letters, arts, and sciences, which enrolls approximately 3,200 students who reflect the highest standards of academic excellence and personal conduct.

The one-year joint certificate program—running from fall through spring each year-has experienced phenomenal growth as a result of student demand. The CCM program has expanded from 26 students two years ago to 60 students last year and then to 112 students in fall of 2015. The CCM program provides a distinctive curriculum combining academic understanding and practical skills development in the focal areas of critical thinking, creative problem solving, and collaborative deal-making.

The Straus Institute's assistant director and CCM Program Director, Tim Pownall, says, "Student evaluations most often mention the words 'empowerment' and 'confidence' as they enthusiastically describe their 'takeaways' from the program. Students who have completed the Certificate have a better sense and appreciation for "What" they are learning in their undergraduate courses at Seaver and "How" to use their new skills to plan for and implement their future goals ... to be strategic. The program's remarkable growth and popularity is largely due to favorable student 'word-of-mouth' year over year!"

To earn the Certificate in Conflict Management, students must complete four Straus Institute and law courses taught by the institute's faculty plus two additional Seaver College upper-level courses. The Seaver Straus Certificate in Conflict Management requires between 14 and 16 units for completion, depending on course selection. Eligibility for the Certificate in Conflict Management requires successful completion of 60 units with a minimum GPA of 3.0.

Jack J. Coe, Jr., Faculty Director – LLM Program

Jack J. Coe, Jr., divides his time among teaching, scholarship, consulting, and arbitrating—activities that, in his case, invariably have an international facet. Any given year will find Coe making multiple trips abroad, carrying a passport full of stamps from around the world. His work also regularly takes him to Washington

DC, New York and Philadelphia. Coe specializes in disputes involving sovereign States, but his many books and articles also address international commercial arbitration in general. As an Associate Reporter for the forthcoming American Law Institute *Restatement on International Commercial Arbitration*, Coe has also devoted several years to a project that will result in an authoritative reference for courts and practitioners throughout the United States.

A Look at the International Commercial Arbitration Program

The International Commercial Arbitration (ICA) curriculum is made up of several highly interactive seminars: Theory and Doctrine, Practice and Procedure; ICA and the Courts, ICA Ethics, and Investor—State Arbitration. There is also an ICA Advocacy seminar that considers both the theoretical and the practical elements of effective case presentation. The instructors are internationally recognized figures in the ICA community—often holding permanent posts at other world-class institutions—who have been attracted by the prospect of bright, highly motivated students pursuing concentrated studies organized by the Institute in a purposeful, systematic manner. Because the LLM program attracts lawyers from all over the world, admittees learn not only from their instructors but fellow LLM candidates, a truly international setting.

Also contributing to Straus' stellar international reputation are the many organized non-classroom events. Only a short jaunt up the coast from Los Angeles International Airport, Straus draws numerous guest speakers to the Malibu campus each year. Many international institutions have come to consider Straus a valued partner. The International Chamber of Commerce (ICC), for example, chose Straus for its March 2015 Southern California Young Arbitrators Conference, attended by lawyers from as far away as Seoul.



Pepperdine Hosts Prestigious Fulbright Scholars for 8th Consecutive Year

For the eighth consecutive year, Pepperdine has been selected to host prestigious Fulbright Scholars from around the globe. Prior Fulbright Scholars have been from Germany, El Salvador, Egypt, Panama, Ukraine, Tunisia, Russia, and South Africa. This year, Pepperdine graduated two Fulbright scholars from Russia, Dmitry Andreev and Elena Cherkasova, both earning concentrations in International Commercial Arbitration.

Before attending Pepperdine, Elena and Dmitry completed their studies at top law schools in Russia and worked in top-tier Russian law firms. Elena graduated from Lomonosov Moscow State University and afterwards practiced law in Sirota & Mosgo Law Firm, concentrating primarily on commercial matters. Dmitry was a student at Moscow State Institute of International Relations (MGIMO—University) and later joined a dispute resolution team of Monastyrsky, Zyuba, Stepanov & Partners.

As part of their Fulbright leadership project, Elena and Dmitry plan to contribute their new knowledge and skills to law practice in Russia, as well as share their experience with the Russian legal community. Elena and Dmitry described the program at Straus as "breathtaking," "extremely interactive and informative," and "entirely chang[ing their] civil law perception of world of ADR and international arbitration."

The Fulbright Program was established by Congress in 1946 and is the largest US international exchange program for students, scholars, and professionals pursuing advanced study, research, and teaching in the United States. Pepperdine will be welcoming a Fulbright scholar from Bolivia in Fall 2015.

Straus Provides Mediation Skills Training in Australia

Assistant professor Stephanie Blondell and Judge Alexander Williams III traveled to Perth, Australia, to train the State Administrative Tribunal (SAT) in a three day course on mediation in a litigated and regulatory setting in March 2015. The Honorable Justice Jeremy Curthoys, a Supreme Court judge who is the president of SAT, welcomed Professor Blondell and Judge Williams warmly.

The SAT judges invited mediators from their community to participate, including four Supreme Court Registrars (full-time mediators in the Supreme Court) and a few restorative justice mediators from the Perth Criminal Court.



Key Findings from the College of Commercial Arbitrators/ Straus Institute Survey of Experienced Arbitrators

Invited by the College of Commercial Arbitrators (CCA), an organization of more than two hundred of the U.S.' leading arbitrators, to report on challenges facing arbitration, Professor Tom Stipanowich conducted an extensive canvas of practices and perspectives among experienced arbitrators. Many new insights emerged from the CCA / Straus survey.

Professional and gender "gaps." Reflecting the increasing legal orientation of arbitration, nearly all survey respondents had background in law practice.


PROFESSIONAL BACKGROUND OF RESPONDENTS



Only 15.4% of respondents were women, mirroring historic barriers to their advancement in the legal profession. The data also show that most respondents lacked sufficient work as arbitrators, although many also work as mediators, early neutral evaluators or case assessors; most expect to do more international arbitration.


Broad experience. Most respondents claimed experience with streamlined or fast-track processes, ad hoc arbitration, and arbitration under non-administered rules; some had arbitrated under final-offer, appellate, and emergency procedures. Most also had served on "tripartite" tribunals with party-appointed wing arbitrators on "tripartite" tribunals. A surprising number had served as sole arbitrators in very large cases.

EXPERIENCE AS SOLE ARBITRATOR



Arbitration and settlement. Respondents during the course of arbitration reported that settlement is becoming increasingly prevalent, that arbitrators experience widely varying rates of settlement and express contrasting views of the scope of their role, if any, in the settlement of disputes (including setting the stage for settlement by process management or, in some cases, med-arb).

EXPERIENCE WORKING WITH PARTIES TO TAILOR ARBITRATION PROCEDURES



Standards for decision-making. Users sometimes express concerns about arbitrators paying heed to applicable law; the survey results indicate that where legal issues are in play, experienced arbitrators tend to be conscientious in paying attention to legal arguments and addressing disputes in a manner consistent with applicable law. However, more than a quarter of respondents "feel free to follow [their] own sense of equity and fairness in rendering an award even if the result would be contrary to applicable law," at least some of the time—a response that indicates the need for additional discussion and investigation.

Negotiation during deliberations. Do arbitrators negotiate with each other? Yes, according to the survey; nearly nine-tenths of respondents said they "negotiate with other members of a tribunal respecting the quantum of damages to be awarded"—again, suggesting the need for further investigation. Another salient statistic related to the leanings of wing arbitrators appointed by individual parties: a majority of responding arbitrators believed "party-arbitrators" are sometimes predisposed toward "their" party even when deliberating on and making awards.

Key Findings from the International Academy of Mediators/ Straus Survey

Straus' survey of experienced arbitrators inspired discussions leading to a parallel canvas of experienced mediators from the US and abroad, co-sponsored by the International Academy of Mediators (IAM). Long-time Straus adjunct Jeff Krivis and fellow mediator Jerry Weiss assisted Professor Stipanowich and Research Fellow Zach Ulrich in developing the IAM / Straus Institute Survey on Mediator Practices and Perceptions. Again, the response produced an unprecedented array of data on what mediators think and do, from preliminary preparations to follow up. Again, some of the results are striking.

Professional, gender and ethnic gaps. As in the arbitrator poll, the great majority (more than nine-tenths) of respondents claimed backgrounds as attorneys. Although a slightly greater percentage of females (22%, as compared to 15% among arbitrators) appeared in the ranks of experienced mediators, the numbers similarly reflect traditional barriers to female advancement in law practice, at least in the US. A more stunning result was the lack of racial diversity in the group—all but two of 130 respondents were Caucasian!

Breadth of practice. Nearly three-fourths of respondents had mediated at least a thousand cases (and some, several thousand). The typical mediator handled multiple kinds of civil cases.

Wide diversity of practice. Mediators' responses to an extensive list of questions about their practices revealed some ways in which practices seem to converge. For example, the great majority (85%) of respondents said they usually or always have counsel submit pre-mediation briefs or other position papers.

However, mediators were much more divided on the question of having counsel share such information with the other side.

Some apparent regional differences. Among the most interesting and thought-provoking aspects of the Survey response are those which suggest that in some cases mediation practices trend differently by region. As the following chart suggests, respondents practicing in the US tended to be more likely than their counterparts abroad to begin mediation with the parties in caucus, and California mediators were collectively more likely to employ this approach than mediators practicing in other states.

Similar trends were observed with respect to the practice of keeping parties in caucus throughout mediation. In addition, US practitioners, and particularly those in California, were more likely than mediators practicing in other countries to use mediator proposals, to offer predictions about how parties' cases would fare in court or arbitration, and to share opinions regarding the strength of arguments made by partiesor counsel.

Perceptions of the impact of counsel. In addition to indicating various ways in which mediators interact with counsel, Survey responses highlight mediators' perceptions about the impact of attorneys.

More than three-quarters viewed the increasing familiarity of lawyers with mediation as a positive development, 90% believed that attorneys usually,

if not always, employed mediation for its given purpose—resolving a dispute. However, the great majority (86%) recognized that at least sometimes, lawyers use mediation for the mere purpose of postponing settlement; half (50%) believed counsel sometimes seek to employ mediation to harm another party.

Tom Stipanowich, Academic Director

As academic director of the Straus Institute and holder of the William Webster Chair in Dispute Resolution, Tom Stipanowich guides the Institute's "think tank" function. He balances his teaching and training responsibilities with a widely varied range of research and writing projects, programs, and presentations, domestically and abroad.

In October, 2014, he delivered a series of lectures and presentations as the New Zealand Law Foundation's International Visiting Dispute Resolution Scholar. Another highlight was his appointment as Max Kade Visiting Professor at Heidelberg University's prestigious Institute of Private Law, where he taught a course on negotiation and gave other lectures, speeches, and workshops in the summer of 2015.

Stipanowich's groundbreaking empirical research has attracted considerable national and international attention. His study of the practices and perspectives of experienced arbitrators was a focus of a meeting of the Institute for Transnational Arbitration and the subject of an entire issue of Columbia's American Review of International Arbitration. The parallel study of experienced mediators was the subject of panel discussions at the annual meetings of the CPR Institute, the International Academy of Mediators (IAM), and other groups.

Stipanowich's passion for history animates his ongoing research on actor-studio disputes and on Abraham Lincoln's career as lawyer, politician, and US President. His colorful program "Rebels on the Lot," which details the backstories of Bette Davis, James Cagney, and Olivia de Havilland at Warner Bros. Studios in the 30s and 40s, was recently the subject of presentations to the International Academy of Trial Lawyers and an audience at a cinema in Wellington, New Zealand! His "Lessons from Lincoln" program is regularly delivered in person and online.

His ambitious plans for the coming year include the conference "Managing Conflict 4.0: A New Wave of Opportunities for Businesses around the Globe" (cosponsored by KPMG and the US Chamber of Commerce) and a new "Community of Thinkers" workshop, as well as an in-depth survey of corporate counsel on resolution of construction disputes. He is most excited about working on a new book, The Lincoln Way:

Abraham Lincoln's Evolution as a Negotiator, Problem Solver and Manager of Conflict, during his sabbatical in the spring semester of 2016.
